### How to reach us:

- \* Follow A75 direction Stranraer, until approximately 15 miles from Castle Douglas you meet a junction indicating Gatehouse of Fleet (A755) to right and Kirkcudbright (A755) to left. Ignore any previous signs for Borgue.
- \* Take the left turn to Kirkcudbright. (A755)
- \* Approximately 3/4 mile, take first right onto B727 Borgue road (no signpost).
- \* Approximately 1/2 mile, take first right, where signposted Carrick 4 miles.
- \* Lennox Plunton is the first farm on right, approximately 1 mile down this road.

Please call at the farmhouse to collect the key to Castleview Cottage. The cottage is approximately 100 yards back up the road from the farm.

At the end of your stay, please return the key to us at the farmhouse, when you are ready to leave.
